students in aspects related to syllabus as well as guides them on recent technologies.

We regularly organize seminars and guest lectures, for which eminent personalities from Industries/FDA are invited as speakers and also the industrial /hospital visits are arranged from time to time for the students. Over a period of time our students have achieved prizes and awards in various state level intercollegiate competitions (Paper and Poster competitions).

The college will continue to strive hard in maintaining highest standards of academic environment by bringing qualitative excellence in teaching.

## INSTITUTE PROFILE

National Centre for Rural Development (NCRD), a registered public charitable trust, was founded in 1991. In the year 2003-04, NCRD widened its educational activities and established the NCRD's Institute of Pharmacy. The institute is bringing qualitative excellence in terms of results, infrastructural facilities, well equipped laboratories, student amenities, well organized library, and computer centre with internet access of 32 Mbps bandwidth, language laboratory & competent faculty.

The institute is located in Nerul which is the biggest residential node of Navi Mumbai. It is situated in a serene and peaceful environment and is easily accessible by rail from the Seawoods station on the harbour line between CST- Panvel and by road from the National Highway-4 or the Palm Beach road providing easy connectivity with all areas of Mumbai, Navi Mumbai Thane & Raigad.

## CLASSROOMS

The institute provides spacious classrooms equipped with modern audio visual teaching aids. It also facilitates maximum interaction between faculty and students.





## LABORATORIES

The institute has well developed laboratories so that students can understand effectively what they have learnt in the classrooms.



## LIBRARY RESOURCE CENTRE

The institute has spacious computerized library with National and International multiple editions with an air-conditioned reading room. It also subscribes National & International journals, periodicals and magazines to keep the students abreast with recent development in field of pharmacy. The library comprises around 4000 books, National journals such as Indian Journal of Experimental Biology, Medicinal and Aromatic Plants Abstracts, Indian Journal of Traditional Knowledge, Journal of Hospital Pharmacy, etc.

The institute provides book bank facility to meritorious students and category students. A student may get a maximum of 5 books per year free of cost.





## GUEST LECTURES/ SEMINARS/ WORKSHOP

Eminent learned professors from the academics and dynamic executives from the pharmaceutical industries are invited from time to time to deliver lectures. This motivates the students and updates their knowledge.



## COMPUTER CENTRE WITH INTERNET FACILITY

The computer centre is equipped with computer terminals of advanced hardware capabilities laced with advanced software programs and twenty four hours leased line internet access with 32 Mbps bandwidth. The Language Laboratory set up in the institute helps to develop and refine English language skills of our students. It offers language module in French language also.



## MACHINE ROOM

Machine room is provided as an added facility to support manufacturing of various pharmaceutical dosage forms like tablets, semisolids, etc. It has equipments like ball mill, double cone blender, triple roller mill, rotary tablet compression machine, etc.





## HERBAL GARDEN

The institute has developed herbal garden that includes a number of medicinal plants to help students to study the Nature's treasures.



## STUDENT'S COUNSELING & CAREER GUIDANCE CELL

The institute has set up a counseling and career guidance cell which ensures overall growth of the students to make them competent professionals to tackle the challenges of the future.

Counseling is done by eminent psychologists who attend to their problems and guide them to enhance their learning abilities and also their solution finding skills. The institute has appointed a student counselor to help students dealing with problems like anxiety, depression, family and friend problems, academic problems, etc.

The parent – teachers and students meet is organized regularly for better interaction.

## MENTORING PROGRAM

The institute has adapted the mentoring program to improve the academic performance of weak students. Under this program, the weak students are identified by their performance in sessional exam and the teachers are appointed as mentors for a group of students. The mentors will schedule meeting with the students, counsel them about studies and track their performance.

## AMENITIES

The campus has various amenities for the students like a hygienic canteen, girls hostel, boys common room, girls common room, indoor/outdoor sports facilities and a huge playground to hold various inter and intra-collegiate sport activities.



## AUDITORIUM

The institute has a spacious air-conditioned auditorium with a capacity of more than 500 seats. It provides a great platform for various co-curricular, extracurricular and professional activities like national and international seminars, workshops, annual day celebration, alumni meet and conferences.





# ADMISSION PROCEDURE

**Intake: 60**

**Eligibility:**

- i) The candidate should be an Indian National;
- ii) Passed the HSC with Physics and Chemistry as compulsory subjects along with one of the subject Mathematics or Biology (Botany and Zoology)

Note: - Other than Maharashtra State Candidates shall be eligible for Institution quota only.

**Selection Procedure:**

Admissions are made through Centralized Admission Process (CAP) by Admission Regulating Authority and Directorate of Technical Education on the basis of merit. Further details are available on website of Directorate of Technical Education (DTE), Maharashtra State, Mumbai [www.dtemaharashtra.gov.in](http://www.dtemaharashtra.gov.in).

**Duration of the Course:**

The duration of the course shall be for 2 academic years with each academic year spread over a period of not less than 180 working days in addition to 500 hours practical training spread over a period of not less than 3 months.

**Course Fees:**

Rs. 80,000 / - as approved by Fees Regulating Authority (FRA) for the year 2019-20.

**Scholarships**

Students admitted to D.Pharm course under Centralised Admission Process (CAP) may apply for various scholarships offered by The Government of Maharashtra and other organizations from time to time.

**Railway and State Transport Concession**

Students aged below 25 years can avail railway and rail transport concession for going to their hometown and coming back during the vacation period. The students should write their hometown address in the application form for availing this concession. Railway concession for suburban travel can also be availed by students.

## **Student Insurance**

The institute provides insurance cover of Rs 2 lakhs through Amartya Siksha Yojana Insurance Policy by National Insurance Company Ltd under the student safety scheme to all students every year.

## **COLLEGE RULES & REGULATIONS**

1. Students must be regular and punctual in attending classes.
2. As per MSBTE rules, 75% attendance is compulsory failing which the concerned students will not be permitted to appear for board examination.
3. Any instance of misbehavior or indiscipline will be reviewed seriously and disciplinary action will be taken.
4. Students must wear their identity cards within the college premises.
5. Use of mobile phones during lectures and practicals is strictly prohibited.
6. No student shall remain absent without prior sanction of leave.

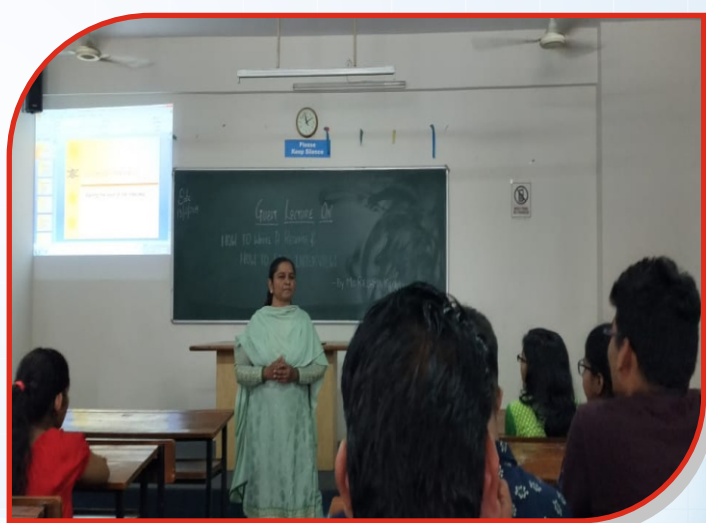
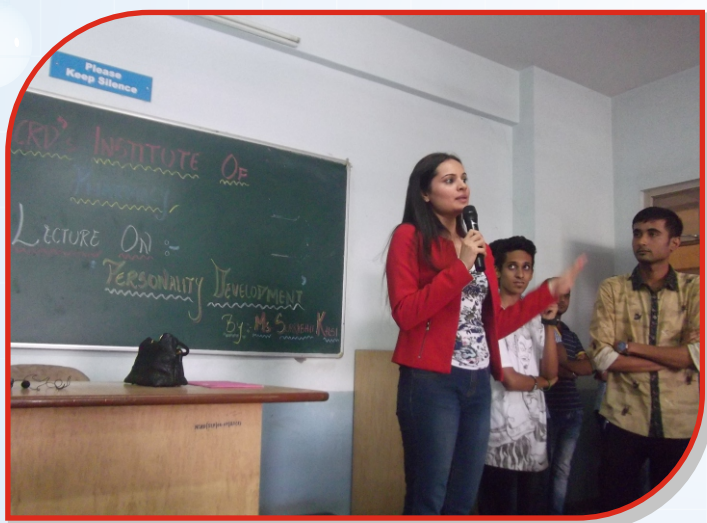

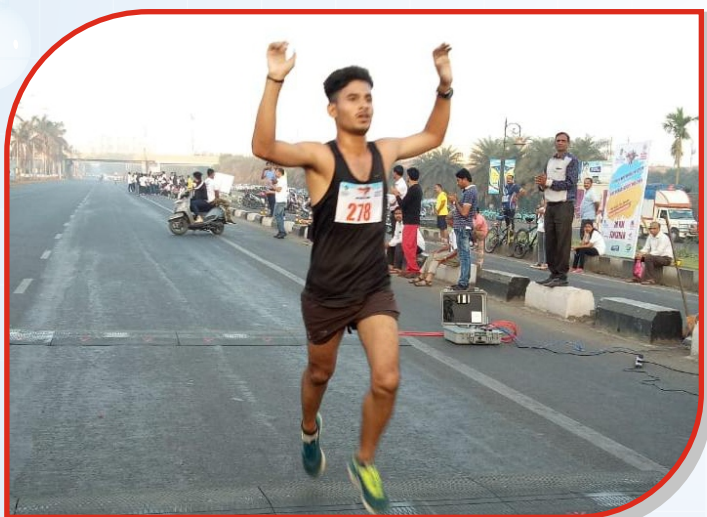

## TRAINING & PLACEMENT

### TRAINING

The first year students, after completion of annual exam, in summer vacation do a market survey where they visit minimum five medical stores and collect information like area required, licenses displayed in the premises, arrangement of medicines, categories of medicines dispensed in a particular locality, etc. They make a project which they present based on which they are given awards for best project and best presentation.

The second year students, after completion of two years course, do training in medical store for 500 hours after which they make project and are then evaluated by viva.

The placement cell regularly contacts various pharmaceutical companies like Cipla Ltd., Sandoz India Ltd., IPCA Laboratories, Walter Bushnell; hospitals like Mahatma Gandhi Mission Hospital (MGM hospital), Terna Sahayadri hospital and retail pharmacy chains like Apollo Pharmacy who recruit students through campus interview. The cell also assists students in placements in community pharmacy/hospital pharmacy/industry by arranging off-campus interviews for a small group of students.

## ANTI-RAGGING CELL

**Action against ragging: Maharashtra Prohibition of Ragging Act 1999 which is in effect from 15th May 1999 has the following provisions for Action against Ragging.**

- a) Ragging within or outside of any educational institution is prohibited.
- b) Whosoever directly or indirectly commits, participates in, abets, or propagates ragging within or outside any educational institution shall, on conviction, be punished with imprisonment for a term up to 2 years and/or penalty which may extend to ten thousand rupees.
- c) Any student convicted of an offence of ragging shall be dismissed from the educational institution and such students shall not be admitted in any other educational institution for a period of five years from the date of order of such dismissal.
- d) Whenever any student or, as the case may be, the parent or guardian or a teacher of an educational institution complains, in writing, of ragging to the head of the educational institution, the head of the educational institution shall, without prejudice to the foregoing provisions, within seven days of the receipt of the complaint, enquire into the matter mentioned in the complaint and if, prima facie, it is found true, suspend the student who is accused of the offence, and shall, immediately forward the complaint to the police station having jurisdiction over the area in which the educational institution is situated, for further action. Where, on enquiry by the head of the educational institution, it is found that there is no substance, prima facie, in the complaint received; he/she shall intimate the fact, in writing, to the complainant. The decision of the head of the educational institution shall be final.
- e) If the head of the educational institution fails or neglects to act in the manner specified in section "d" above when a complaint of ragging is made, such person shall be deemed to have abetted the offence and shall, on conviction, be punished as provided for in section "b" above.
